FINANCIAL PORTION

The Fiscal Officer began the Financial Portion of the meeting by reading a summary of the Payroll, Utilities, and Truck Payments. Other payments were read that were also being approved.

Several PO's were approved for the Fire Departments for fire contracts. Also, TEMS, Wintersville, and Richmond for EMS contract payments. A PO was approved for Roioano Contracting for the Four Seasons Project. A Blanket Certificate was approved for Repairs and Maintenance. Brenda Powley ask when the Four Seasons project would start. The Contractor moved in equipment today.

REGULAR PORTION

Brian moved to accept the September meeting minutes, Bub second. All in favor

Bub moved to accept the September financials, Brian second. All in favor.

FIRE LEVY

The Board ask the Fire Departments if they had any bills to report for the Fire Levy expense report. They had none.

RESOLUTION TO REMOVE the EMS LEVY

Bub moved to accept the third and final reading by Title only of the Resolution to remove the EMS 1990 1.5 Levy due to joining TEMS and the Seven Ranges District. Brian second, all in favor.

REMOVAL OF OLD FIRE LEVY'S

It was discussed that if the Fire Levy passes, A resolution will be prepared for the November meeting to remove all the older Fire levies. If the Levy does not pass a Resolution will be prepared to remove the old levies only in the Seven Ranges District area. This will be passed as an emergency Resolution because of the timing.

Sam wanted to thank everyone who participated and who came out. Sam added he wanted to personally thank Bub and his wife for all the work they did, cleaning and setting up and all the extra work. Also thanking Brian Applegarth and Darla. Brian Sayers was thanked for organizing the car show.

Bub added that once he gets Four Seasons done, they'll be two projects hanging, which is Connie Street 60-70 tons and Briar hill which is 300 ton, if there is no money left then they'll have to wait. The Fiscal Officer explained that there might be a little left for blacktop but no labor. That's how it is unfortunately. But as soon as these projects are done and we have an idea of the cost if there's anything left, I'll let you know.
